

Global Higher Education LLM Landscape: ChatGPT Edu – All Academic Domains

Run date: 4 May 2026

Scope: All *.edu, *.ac.*, and *.edu.* academic domains globally; World Bank High Income and Upper-Middle Income countries.¹

Product: ChatGPT Edu (OpenAI) – campus/system-wide institutional agreements.

Search strategy: Supplier-side checks (OpenAI announcements, NextGenAI) followed by targeted domain-scoped searches across major academic TLDs.

Evidence standard: Primary evidence = URL on a university or national body domain confirming an institutional agreement. Secondary evidence = supplier press release or credible news source.

Section 1 – Methodology Note

Searches were conducted in English only in this run; non-English searches are planned for the next round of reports and are noted where relevant in Sections 4 and 5. An inverted search strategy was applied: supplier-side announcements were scraped first to identify named institutions, followed by targeted Google Dork searches of the form "ChatGPT Edu" site:*.edu.au (and equivalent for each TLD) to surface university IT pages and provost announcements not covered in press releases. Where a university domain page was found, it was navigated and verified before inclusion.

URL handling note. In the table, the *Primary AI URL* column carries the single most authoritative institutional URL for the deployment. The *Other AI URLs* column carries secondary or corroborating links, separated by semicolons. All URLs in footnotes are formatted to ensure they are clickable in this report. The output format is as follows:

Scope notes:

- UK universities (*.ac.uk) are covered in a separate UK HE LLM Landscape report and are excluded here to avoid duplication, with the exception of London Business School (london.edu), which uses a .edu domain for commercial purposes.
- System-wide or national agreements (e.g., California State University system, CRUI Italy) are listed as a single entry with a note on the number of institutions covered.
- Entries marked **[NATIONAL]** indicate a government-level or rectors' conference agreement covering multiple institutions.
- Entries marked **[PILOT]** indicate a time-limited or partial deployment not yet confirmed as campus-wide.
- Where a deal covers staff only, students only, or both, this is stated explicitly in column 4. The type of staff (academic, administrative, all) is noted where known but is treated as secondary to the staff/student distinction.

Section 2 – Supplier-Side Secondary Evidence

2.1 OpenAI Education for Countries (launched January 2026)

OpenAI launched its Education for Countries initiative on 21 January 2026 as a new pillar of the broader OpenAI for Countries programme.² The first cohort comprises eight countries: Estonia, Greece, Italy (via CRUI),³ Jordan, Kazakhstan, Slovakia, Trinidad and Tobago, and the United Arab Emirates. Each country agreement provides access to ChatGPT Edu, GPT-5, Study Mode, and Canvas,⁴ customised to national learning priorities. OpenAI has stated that a second cohort will be announced later in 2026.

Estonia is the most advanced deployment: ChatGPT Edu has been deployed nationwide across public universities and secondary schools, reaching more than 30,000 students, educators, and researchers in its first year under the national AI Leap programme. A longitudinal research partnership with the University of Tartu and Stanford University is underway to measure learning outcomes among 20,000 students.^{5 6}

Italy's CRUI⁷ signed what was described as Europe's first contract of this scope in July 2025, covering all Italian public universities.⁸ Rollout began in September 2025 following technical readiness sessions in late July. A domain search for "ChatGPT Edu" site:*.it surfaced a number of Italian university pages with implementation guidance, including the University of Naples L'Orientale.⁹

The evidence for the remaining six countries in the first cohort (Greece, Jordan, Kazakhstan, Slovakia, Trinidad and Tobago, and the UAE) is largely confined to the OpenAI Education for Countries page and government press releases. Country-specific and language-specific searches will be conducted in the next round of national reports. The absence of university-domain evidence for these countries reflects the national-level agreement model – individual institutions are not expected to publish their own announcements – rather than necessarily a lack of activity.

2.2 NextGenAI Consortium

OpenAI's NextGenAI consortium, announced on 4 March 2025, brings together leading research universities to accelerate AI research and deployment.¹⁰ The founding members are thirteen universities – Caltech, the California State University System, Duke University, the University of Georgia, Harvard University, Howard University, MIT, the University of Michigan, the University of Mississippi, The Ohio State University, the University of Oxford, Sciences Po, and Texas A&M University – together with Boston Children's Hospital, the Boston Public Library, and OpenAI. The consortium provides research access to frontier models and funding for AI projects; it is distinct from, and does not in itself constitute, a ChatGPT Edu campus-wide deployment agreement.

2.3 Samsung SDS and LG CNS – South Korea (April 2026)

On 27 April 2026, Samsung SDS and LG CNS each secured sales rights to distribute ChatGPT Edu to South Korean educational institutions.¹¹ Samsung SDS is currently piloting ChatGPT Edu with approximately 90,000 users at Korea National Open University (KNOU)¹² (knou.ac.kr). No campus-wide confirmed agreements at

individual Korean universities have been independently verified at the time of this report, but the reseller agreements signal imminent deployments.

2.4 India Cohort (February 2026)

On 18 February 2026, OpenAI announced a coordinated India cohort of six institutions with campus-wide ChatGPT Edu access: IIT Delhi, IIM Ahmedabad, AIIMS New Delhi, Manipal Academy of Higher Education (MAHE), the University of Petroleum and Energy Studies (UPES), and Pearl Academy.¹³

2.5 OpenAI AI-Powered Universities (February 2026)

In the announcement of the California State University system agreement on 4 February 2026, OpenAI named a group of institutions as “AI-powered universities”: Arizona State University, ESCP Business School, Harvard University, London Business School, the University of Oxford, and the Wharton School of the University of Pennsylvania.¹⁴ This designation does not itself constitute a new agreement but confirms active ChatGPT Edu deployments at each named institution.

Section 3 – Confirmed Institutional and National Agreements

The following table (starting on the next page) lists all confirmed or credibly reported ChatGPT Edu institutional agreements found across *.edu, *.ac.*, and *.edu.* academic domains.

Entries are sorted alphabetically by country, then by short name of institution.

Non-English evidence (with embedded URLs) in the *Other AI URLs column* is flagged with the relevant ISO 639 two-character language code in brackets.

To avoid the complexity of switching to an A4 landscape mode but to maximise space use the table font size has been dropped to 10-point.

Section 4 – Notable Absences and Signals

Several major universities were searched but no campus-wide ChatGPT Edu agreement was found. These are listed as signals for the next run, as they are actively engaged with AI tools and may have agreements in place that are not yet officially announced. Country-specific and language-specific reports will expand on these entries.

Section 5 – Observations and Signals for Next Run

The global sweep of ChatGPT Edu deployments reveals several structural patterns that will shape the next run.

National and system-level agreements are the dominant model outside the US. In Europe (Italy, Estonia), the Middle East (UAE, Jordan), and Central Asia (Kazakhstan), the agreement is made at government or rectors' conference level and cascades down to individual institutions. This means that individual university domain searches will often fail to find evidence – the primary evidence URL will, at least initially, be on a government or national body domain, not a university domain. The absence of university-domain evidence for Slovakia, Greece, and Trinidad and Tobago should not necessarily be read as a lack of activity.

The US market is institution-by-institution. No national or statewide US agreement on ChatGPT exists; each university negotiates separately. The California State University system (23 campuses, \$17M contract) is the largest single agreement. UC Davis's renewal at a 40% price reduction (\$144/year, down from \$240) suggests that OpenAI is actively competing on price to retain and expand its US HE market share. At the list price of approximately \$200 per user per year, a campus of 50,000 students and staff represents a potential annual commitment of \$10M – a significant sum at a time when many universities in the US, UK, Netherlands, Australia, and New Zealand are under financial pressure.

South Korea is a key next major market. The Samsung SDS and LG CNS reseller agreements of April 2026 signal that OpenAI is using distribution partners rather than direct sales to enter the Korean market. KNOU's 90,000-user pilot is the largest single deployment in the Asia-Pacific region outside Australia.

India has accelerated rapidly. The February 2026 cohort of six institutions – IIT Delhi, IIM Ahmedabad, AIIMS New Delhi, MAHE, UPES, and Pearl Academy – represents a significant shift from the single confirmed entry (IIM Ahmedabad) in the previous run. A second wave of Indian deployments is likely before the end of 2026. Country-specific searches using *.ac.in and *.edu.in domains, and Hindi-language searches, are planned for the next round.

Latin America is emerging. Insper (Brazil) is described by OpenAI as a model for Latin American expansion. The next run should include language-specific *.edu.br, *.edu.mx, *.edu.ar, and *.edu.co domain searches. (No non-English language searches were conducted in this run.)

The Philippines and Singapore are active. Mapúa and EtonHouse are early movers in Southeast Asia. NUS and NTU (Singapore) should be specifically searched in the next run.
